
#### Theme-based recognition

- Qualify for theme-based recognition without reaching other awards levels
- Indicate themes by filling up an Annexure for each theme at the end of the Application Document
- Themes include:

  - ▼ Climate Change
  - Energy Management
  - Water Management
  - Waste Management
  - Resource Use Efficiency
  - Occupational Health & Safety
- Community Empowerment
- ▼ Base-of-Pyramid Solutions

#### Sector-based recognition

- No additional fee
- Applicable only where three or more applicants from same sector
- Applicants are assessed only for main Awards (themes not relevant here).
- No additional Annexures needed
- · Single winner is selected per sector

# Criteria for Evaluating Themes

**Exceptional:** How is the company's approach to this theme unique?

**Important:** What was the thought-process in prioritising this theme?

**Resources:** How were initiatives falling under this theme implemented?

Impact: Did this lead to meaningful systemic change?


**Potential to Emulate:** To what extent can this model be replicated / scaled up?

Benchmark: Who else has succeeded in doing this?





### Assessment Methodology



The CII-ITC Sustainability Awards' transparent and rigorous assessment process is based on the Sustainability Excellence Model, developed on methodology adapted from the internationally acclaimed European Foundation for Quality Management (EFQM) approach wherein equal weight is assigned to "Enablers" and "Results".

A pool of specially-trained assessors from a range of professional backgrounds carry out the assessment over 6 months utilizing about 1,000 hours per application. The results drawn from each assessment are reviewed by the Jury in two stages before a final decision is taken.



#### **FAQs**

#### How are the CII-ITC Sustainability Awards unique?

- \* Comprehensive: Considers all products, services and activities
- Rigorous 2-stage assessment
- : Renowned Jury approves / decides

#### What is the purpose of theme and sector-based recognition?

- Theme: It offers an applicant the opportunity to highlight outstanding achievement in a specific area worthy of recognition even if the applicant does not excel in every field.
- Sector: Best performer in the sector, subject to a minimum of applicants from same sector

#### How is theme-based recognition related to the Awards?

- A company must enrol in the Awards in order to be eligible for theme-based recognition
- \* Applying for theme-based recognition is optional
- ? An applicant may opt for a maximum of 2 themes

# Information for Applicants

- The application fee is non-refundable and non-transferable
